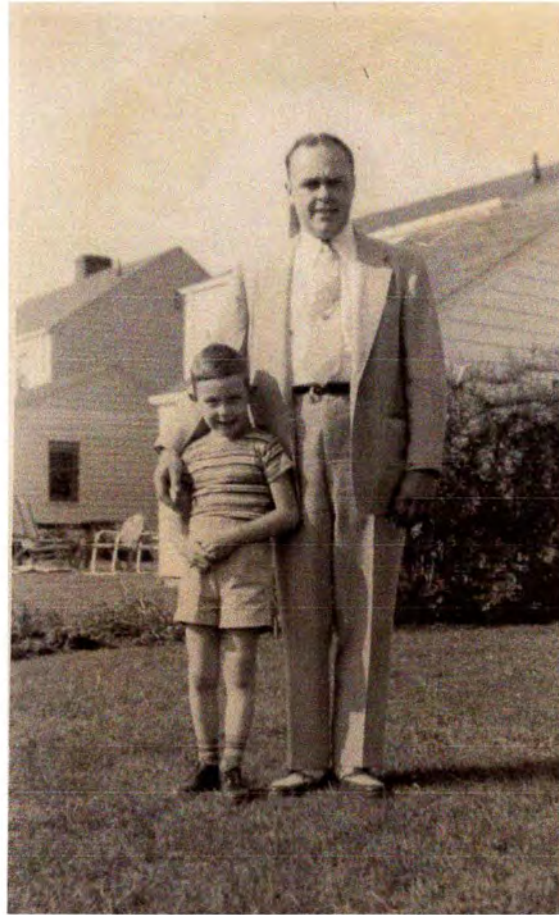

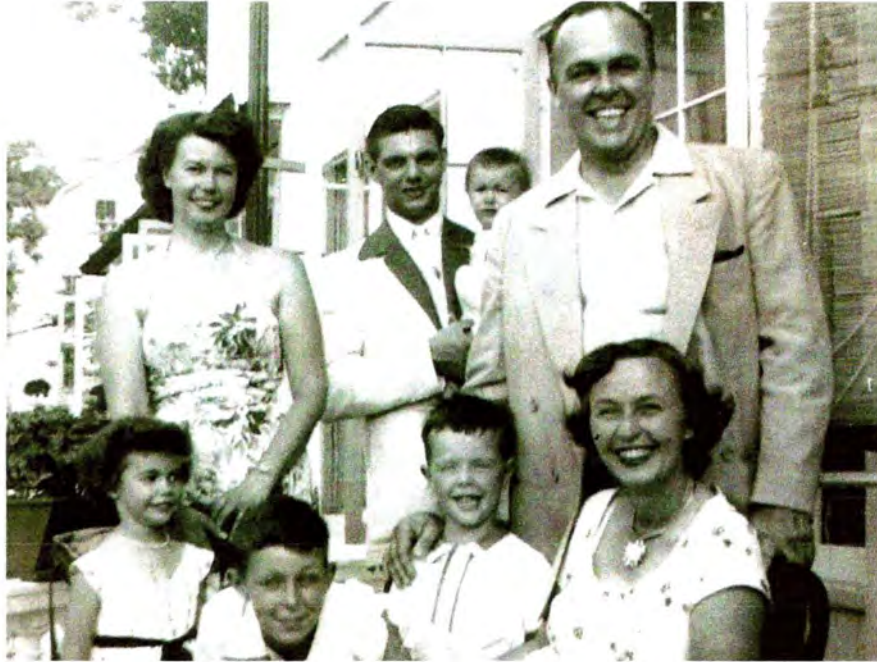
**7/51: Contract ended. Decided to purchase own business.**

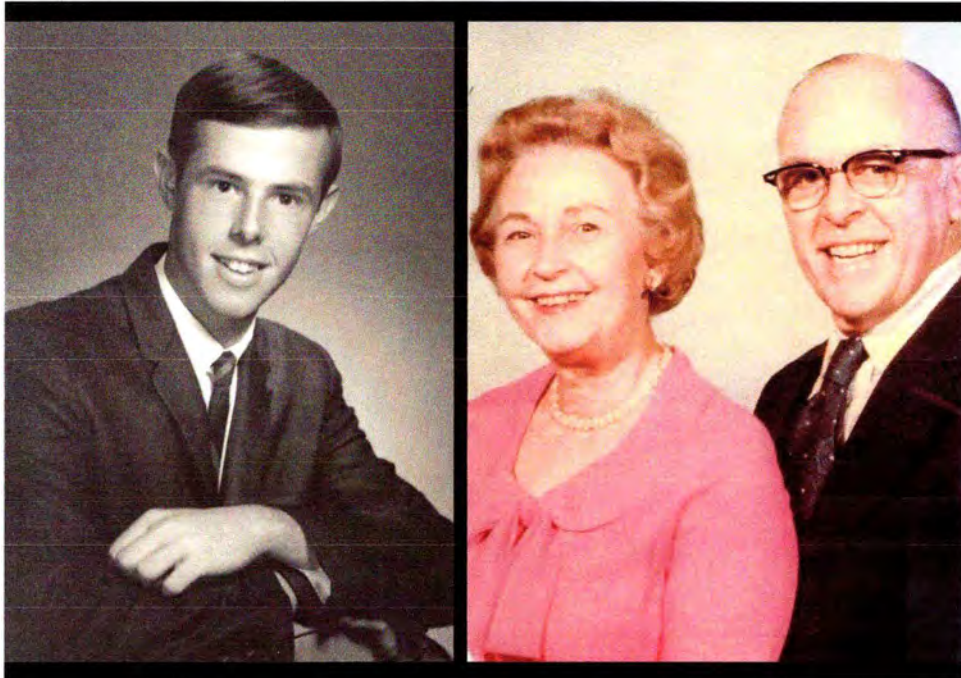
**11/74: Sold Mercedes Benz business to Clayton Gengras. Retained property at 355-359 Farmington, Avenue, Plainville, Connecticut.**

**5/6/79: Certified Lay Minister in the United Church of Christ**

**2/19/80: Congregational Church of Plainville by vote of the Diaconate extended the privilege of conducting baptisms, funeral, hospital calling, communion, and preaching. He did occasion preaching and gave talks for the Guideons.**

# KENNETH ANDREW PAUL STROBLE TIMELINE

**1980:** Accepted job as Permanent Panel Member of the Labor Relations Board until 1982.

**1982:** Sold property at 355-359 Farmington, Avenue, Plainville, Connecticut to Industrial Design Consultants, Richard Russell, President.

**1982:** Appointed to Labor Relations Board until 1986 by Governor William O'Neill.

**1984:** Submitted resignation to Governor William O'Neill effective April 30, 1984 due to illness. Contract had two more years to go, but was unable to attend meeting due to his health.

**10/17/84:** Died and went to be with the Lord.
